Minutes of the Parish Council Meeting held on 1st March 2023 at The Fiddle Drill, Manor Farm, Goodmanham

98. Apologies, Dispensations and Declarations

Cllrs Mary Rook and Richard Cooper; ERYC Leo Hammond. Cllr Rudd advised that he could not comment on Planning applications as he is a Member of Planning Committee at ERYC.

99. <u>Public Session</u> – it was reported that the geologist's visit to look at use of building stone has been arranged for 20th March. Permission has been granted by a number of property owners for inspection of their buildings.

Cllr Rudd reported that the ETYC Council Tax will increase by 4.99% (2% of this for Social Care). This would represent a increase of £6.72 for a Band D Tax payer. The Fire Service will increase by about 5%, and PCC 5.9%. There will be extra money made available for highway dressings, and no change to basic services.

A Business Day is being held at Bridlington Spa on 9th June.

A pilot scheme for LED lighting is being introduced on main roads in the area. This will cut energy costs.

A defibrillator is being installed in all Household Waste Recycling Centres.

100. Minutes of the Meetings held on 4th January 2023

Resolved that the minutes of the meeting of 4th January 2023 be approved

- 101. <u>Matters arising</u> the site for the QEII memorial bench has been cleared, and it will be installed before Easter. Market Weighton Town Council agreed a 50% contribution, and have been invoiced.
- 102. <u>Highways</u> Cllr Hammond has advised that Highways are monitoring the verge which has been damaged. It was felt that action is needed as the damage is close to a BT inspection chamber. The verge next to the Church has been damaged further due to heavy vehicle usage increasing the potential of undermining.
- 103. <u>Car Park</u> the Clerk reported on email correspondence with ERYC regarding trailer storage in the Car Park. ERYC had included a clause in the lease which prohibited trailer storage, and have insisted that this is enforced, threatening to take action themselves if the Parish Council takes no action. The owners have been contacted and indicated that they were unwilling to move the trailers. However, it was reported that they have been offered an alternative storage location. If this offer is taken up it would deal with this issue.
 - Other issues in the Car Park had been reported including blocking in vehicles and overnight use by camper vans. It was noted that the Parish Council rely on the goodwill of users as there are no resources to take enforcement action. Line markings help, but wear off quickly due to the loose surface. Permanent surfacing would be expensive and unlikely to be affordable for the Parish Council.
- 104. Community Governance Review the Clerk advised that ERYC are undertaking a Community Governance Review of Parish Councils which gives an opportunity to consider boundary amendments or changes to the number of Councillors. The Council felt that there was no need for any changes in Goodmanham.

Resolved that ERYC be advised that the Council see no need for any changes to the current arrangements

- 105. <u>Emergency Plan Review</u> it was agreed at the last meeting that the Emergency Plan would be reviewed. Subsequently ERYC have written asking for the Council to update the plan, which includes a new format. It was agreed that the Clerk would complete the Plan following consultation with Councillors.
- 106. <u>King's Coronation</u> it was reported that the Events Group had met and proposed holding an event on 7th May for the Coronation similar to the Jubilee event. It would include a "Big Lunch" and the opportunity to watch the Jubilee concert on a big screen in the evening. The group intend to do some fund raising, but asked if the Council could submit a grant application to cover core costs. ERYC have approved a grant fund that could cover up to £500 of the cost.

Resolved that the Council

- 1. Support the proposed Coronation event
- 2. The Clerk be authorised to submit a grant application to ERYC for up to £500 to cover core costs in consultation with Council and report back to the next meeting.
- 3. Subject to grant approval, expenditure of up to £500 on the Coronation event be authorised.
- 107. <u>Election</u> the Clerk circulated information provided by ERYC on nominations for Councillors for the Elections on 4th May. Nominations can be submitted between 17th March and 4th April, and ERYC have asked that they are hand delivered. Briefings have been arranged for Clerks and Candidates on the arrangements.

22/04061/PLF | Conversion and alterations to existing redundant buildings to form 2 dwellings, 2 holiday cottages and 1 residential annexe to existing farmhouse | 1 Brook Farm

The Clerk had circulated a report. Whilst accepting the principle of residential use of this site, and welcoming the retention of historic farm buildings a number of concerns were raised including parking both for occupants and residents, vehicle turning provision, architectural detail, contamination/ asbestos, and bin storage.

Resolved that the Clerk submit an objection to the application in consultation with Councillors based on the concerns raised.

22/03137/PLB | Installation of replacement windows on west elevation (retrospective application) | All Hallows Cottage Main Street
